HAVING EXAMINED the alleviation plan proposed by the Secretary General for the year 2023,

THANKS those Member States which have paid their contributions and arrears,

ADOPTS the creation of an ad hoc commission in charge of proposing an alleviation plan and reviewing the scale of contributions of Member States for submission to the 56th session of the Executive Council. The commission is composed of the following countries: Qatar, Saudi Arabia, Bahrain, China, Russia, Niger, Cameroon, Senegal and Côte d'Ivoire.

- To create a regional platform in Africa comprising a regional office, a regional training centre, a regional warehouse and a regional emergency center;
- To create a regional office located in Yaounde, Cameroon;
- To establish Portuguese as the 7th official language of ICDO;
- To set up a deadline not later than two weeks before the holding of the Executive Council and the General Assembly for the submission of candidacies to the position of President of the Governing Bodies as well as Members of the said Bodies;
- To set the limit for the number of Executive Council members at 25.

INVITES the Secretary General to implement these decisions.
