

# Protocol and recommendations of the ICDO Financial Commission 19.06.23-20.06.23

In accordance with the decisions of the Executive Council, the Financial Commission was held from 19 to 20 June 2023 and was composed of the following members:

- Mr. Azamat MAMBETOV, President of the Financial Commission,
- Mr. El Hadi BOUNOUA, Member of the Financial Commission,
- Mr. Irakli ARABIDZE, Member of the Financial Commission.

The meeting opened with a welcoming speech by the Secretary General, Madame Mariatou Yap, wishing to all participants a fruitful work.

The following members of the Permanent Secretariat were present during the work:

- Mr. Andrey KUDINOV, Deputy Secretary General of the ICDO,
- Mr. Lotfi AUADI, Financial Manager of ICDO.

In the course of its work, the commission analyzed the following issues:

### 1) Implementation of the ICDO budget in 2023.

At the 55th session of the Executive Board, the budget for 202 3 was approved in the amount of 3,077,100 Swiss francs, for the following articles:

- Article 1: Official events CHF 220,000.
- Article 2: Employee costs CHF 1,582,000.
- Article 3: Business trips CHF 110,000.
- Article 4: Training and technical assistance CHF 600,000.
- Article 5: IMCC CHF 85,000.
- -Article 6: Accounting and legal costs CHF 223,600.
- Article 7: Functioning of the Secretariat 47,000 Swiss francs.

- Article 8: Maintenance of the building and vehicle fleet CHF 198,500.
- Article 9: Miscellaneous expenses CHF 11,000.

The Commission was provided with documents on the receipt of contributions from member countries in 2023 to the ICDO accounts in the amount of CHF 1,011,224.14. In addition, ICDO received CHF 671,482.61 (CHF 192,200 for the Regional Office in Cameroon) as an administrative contribution for humanitarian projects and CHF 124,858.40 from the placement of funds for humanitarian projects and the reserve fund on deposits.

The Commission concluded that the funds received were not sufficient to fully cover the entire budget in fiscal year 2023 and that a transfer from the Organization's reserve fund was required. The reserve fund as at 31 May 2023 is CHF 5,191,216.29.

The Commission noted that the reserve fund is decreasing annually (2020 - 7,500,000, 2021 - 6,400,000, 2022 - 5,050,000, forecast for <math>2023 - 4,500,000).

The Commission drew attention to the insufficient work done to reduce arrears, which led to an increase in arrears. As of May 31, 2023, the amount of arrears in contributions was CHF 9,167,861.50 (CHF 8,111,382.00 in 2020, CHF 8,374,766.00 in 2021, CHF 8,560,315.66 in 2022), which greatly complicates the work of the Organization.

Commission Recommendation No. 1 to the Executive Council to consider not including in members of the Executive Council States that have been in arrears for more than 3 years. Members of the Executive Council should honor their commitments and set an example for other States with regard to the payment of contributions.

The main observations of the commission in the detailed analysis of budget execution by chapters:

a) Article 1 – "Official events"

The Commission focused on the travel of members of the Permanent Secretariat to Mauritania and Moscow (random verification) and concluded that the Secretary General was not fully complying with Decision 8 of the 55th session of the Executive

Council, as well as the recommendations of the Financial Commission 2022 (the Secretary General's business class ticket to Mauritania costs CHF 2,877.00 and to Moscow CHF 6,957.00).

The Commission drew attention to the fact that the Secretary General was accompanied by her assistant on all trips, which placed a significant additional burden on the budget and expenditure of appropriations.

Commission Recommendation No. 2 to rationalize travel expenses by reducing the budget burden as much as possible, in particular reducing the purchase of business class tickets, as well as optimizing the composition of the ICDO delegation participating in missions.

b) Article 2: "Expenses for employees"

The mandatory salary costs of the ICDO Permanent Secretariat amount to 1,582,000 Swiss francs, which is barely covered by the total amount of contributions (1,592,000 Swiss francs) if paid in full by all ICDO member countries. This chapter of the budget is the costliest and requires reduction, as well as austerity (revision of salaries and organizational structure of the Permanent Secretariat without compromising the quality of realization of tasks).

The Commission expressed concern following the report of the financial manager on the procedure for purchasing air tickets for the Organization's events and meetings. Part of the tickets is purchased by an employee of the IMCC, which is not his direct function and, according to the words of the employee of the IMCC, significantly distracts him from performing his main functions.

**Recommendation of the Commission No. 3** to entrust the staff of the Permanent Secretariat with tasks in accordance with those prescribed in their employment contracts and to centralize as much as possible the procedure for purchasing tickets for ICDO events.

The staff costs of the Permanent Secretariat have increased by 6% compared to 2022 and amount to CHF 1,582,000 in accordance with the approved budget, which is a cause for concern. Generally, when an organization has financial difficulties, one of

the ways to maintain financial stability is to optimize the organization's personnel, but we find that the organization's staff is fully preserved.

**Commission Recommendation No. 4** to immediately develop a cost optimization plan for the Organization and submit it to the Executive Council for approval in 2023.

To present a midterm plan of options for optimizing the staff of the organization, reducing the cost of maintenance of the Secretary General and his deputy, optimizing the travel costs of Secretariat's staff (refusal to travel in business class, optimizing the composition of members of the ICDO delegation taking part in business trips and other activities), reducing the cost of performing tasks not related to the core functions of the Organization.

### c) Article 3 – "Business trips"

Recommendation of the Commission No. 5 to optimize the costs of organizing business trips for employees of the Permanent Secretariat. The Commission saw a risk that the balance of the mission's budget might be insufficient before the end of the year. The Commission proposes, to the extent possible, to make use of the facilities of IMCC for organizing meetings via videoconference.

### d) Article 4 – "Training and technical assistance"

Recommendation of the Commission No. 6 having considered the training plan for 2023, the Commission recommends that the Secretary General and the Permanent Secretariat strictly comply with the training plan and, in accordance with the guidance of Decision 5 of the 55th session of the Executive Council, use the positive balance of the budget for trainings.

### e) Article 5 – "IMCC"

Documents and equipment purchased for the International Monitoring and Coordination Centre and the Permanent Secretariat have been presented to the Commission.

The Commission, having taken note of the report of the IMCC staff member, notes with satisfaction the considerable efforts made in the development of the International Monitoring and Coordination Centre and the Permanent Secretariat.

**Recommendation of the Commission No. 7** to draw up a detailed annual plan for the acquisition and upgrade of hardware and software for IMCC and the Permanent Secretariat, as well as to concentrate development for the use of information and products provided for Member States.

f) Article 6 – "Accounting and legal expenses"

The Commission noted the stability of expenses related to accounting and legal costs in the first semester of 2023. The positive balance as of May 31, 2023 can largely cover the fiscal year.

g) Article 7 – "Functioning of the Secretariat"

The Commission considered the information provided.

h) Article 8 – "Maintenance of the building and vehicle fleet"

The Commission considered the information provided.

i) Article 9 – "Other expenses"

The Commission considered the information provided. The costs of various expenses, in particular bank charges, are minimal compared to the allocated budget.

(2) Analysis of the budget and functions of the Regional Office in Cameroon.

The Commission took note of the establishment of the Regional Office in Cameroon as a sign of the Organization's development and examined the regional office's total budget amount of CHF 192,200 for 2023 (12% of total annual contributions).

The Commission, in the process of a detailed analysis of the budget of the Regional Office in Cameroon, expressed concern about the salary of the head of the Office permanently residing in Cameroon (7500 Swiss francs + 1000 Swiss francs for miscellaneous expenses), which, at first glance, is too expensive and unjustified.

**Recommendation of the Commission No. 8** to submit the issue of the budget of the regional office for discussion at the session of the Executive Council in 2023 and hear the report on the activities and financial report of the head of the Regional Office.

### (3) Report of the Deputy Secretary General on humanitarian projects.

The Commission heard a report presented by the Deputy Secretary General of the ICDO on the implementation of humanitarian projects, in particular those implemented in 2022 and 2023, and notes with satisfaction the high level of their implementation. The submitted reports contain all the information on the implementation of humanitarian projects (memorandums, contracts, consignment notes, certificates of completion, photo and video reports). The Commission notes with satisfaction that, thanks to humanitarian projects with the financial support of the Russian Federation, substantial support is provided to the national civil defense services of the ICDO member countries, as well as financial support to the Permanent Secretariat, which in 2023 is more than CHF 796,341.00 (26% of the Organization's budget).

The Commission expresses its gratitude to the Russian Federation for its continued financial support for the implementation of humanitarian projects and hopes that the credited administrative costs will have a positive impact on the ICDO reserve fund.

#### Conclusion

The Commission stresses that the level of organization of the Financial Commission, the level of transparency of the information provided, as well as the positive implementation of previous recommendations of the Commissions and decisions of the Executive Council have improved.

The Commission requests the Secretary General to circulate the protocols and recommendations of the Financial Commission 2023 among ICDO Member States.

### Campaign to support the organization's resilience:

Based on the report of the Secretary-General of the Organization and the Finance Committee for the years 2021 to 2023 and the recommendations of Executive Council No. (53-54-55) and the report of the Deputy Secretary-General and his message sent to the Council on various administrative events excluding the financial tasks and the adoption of Executive Council feature No. 55. With regard to the bilateral approval from both the Secretary-General and her deputy regarding both administrative and various expenses, in addition to the misuse of authority in employment and the lack of essential partnerships such as paying subscriptions, various transgressions, and pending cases in the courts

After reviewing the attached documents in this regard, and to ensure financial and administrative control and enable the organization to carry out its tasks and sustain it, we therefore propose the following:

#### Recommendation No. 1:

Activating the constitutional and pivotal role of the International Civil Defense Organization in accordance with Article No. 2 of the Constitution. Considering that the organization is the international platform for civil protection, civil defense, and emergency situations, the focus must be on the following:

- 1. Training programs and building national cadres for member states;
- 2. Auditing and providing consultations to improve specialized capabilities;
- 3. Technical assistance by supporting the teams technically and providing assistance to provide equipment, enhance capabilities, and provide technical aid to countries in need or in distress;
- 4. Strengthening international cooperation in the fields of civil protection, disaster management, risk analysis, and means of forecasting and early warning.

#### Recommendation (2)

Begin taking immediate administrative measures and removing countries from the Executive Council whose arrears exceed more than 3 years unless they adhere to the settlements approved by the committee specializing in settling arrears situations. If countries are unable to pay these arrears, isolation will be activated to radically end this problem.

#### Recommendation (3)

Cancellation of any regional offices that were previously approved to stop the financial burden and the exorbitant costs incurred by the organization, especially since it did not provide any benefit to the member states, causing the already bloated financial deficit to inflate.

#### Recommendation (4)

Activating Resolution No. 8 of the Executive Council at its session No. 55, Recommendation No. 1 of the Finance Committee, and Recommendation No. 2 of the Deputy Secretary-General, related to reducing travel expenses to a minimum for official events by canceling business class travel and reducing expenses For the Secretary-General and his deputy to create a central system for tickets, which, unfortunately, the General Secretariat did not adhere to.

#### Recommendation (5)

Forming a committee headed by the Chairman of the Executive Council and the membership of his deputy and the Chairman of the General Committee to reconsider the recruitment mechanism so that it is carried out according to a clear mechanism, taking into account the representation of all continents and clarifying the conditions for application and acceptance, the required tasks, the nature of contracts, and qualifications.

#### Recommendation (6)

Reducing the General Secretariat's staff to the operational minimum while retaining specialists who perform key functions of the organization's work.

#### Recommendation (7)

Organizing sub-meetings through video communication technology, not sending sub-secretariat employees for non-essential tasks, and reducing the secretariat delegation to the minimum.

### Recommendation (8)

Develop a fixed training plan and adhere to it literally, not exceeding the required limit, taking into account the needs of countries, and distributing seats according to the types of training, in addition to accrediting the participants by the scientific committee for training and the international communication point in the organization to achieve the maximum benefit, as training and the exchange of experiences are considered among the foundations of this organization.

### Recommendation (10)

Ending any regional meetings for a specific group of countries and focusing on the main meetings or meetings of committees and technical teams only.

#### Recommendation (11)

Stop all legal procedures taken against former international civilian employees of the Secretariat, taking into account that all administrative and financial responsibilities fall on the Secretary-General in accordance with Article No. 27 of the Constitution, not to mention the unjustified costs of these procedures (law firm fees and other judicial costs). Relevant amounts), whether paid or expected to be paid in the future.

Ending the current procedures at the criminal or civil level and settling all compensation due to former civilian employees of the General Secretariat in accordance with their respective employment contracts.

#### Recommendation (12)

The accounts employee is committed to the previous Executive Council decision regarding the approval by both the Secretary-General and his deputy of all expenses and various financial details in a bilateral and transparent manner and the submission of financial reports to the Chairman of the Executive Council and his deputy upon request.

#### Recommendation (13)

Developing an integrated plan by the Secretary-General and his deputy to reduce expenses and reduce the budget as much as possible and to solve the outstanding problems in which no change has occurred since the departure of the Acting Secretary-General and not to use the reserve except with the approval of the Executive Council and in accordance with specific controls and for reasons of necessity in order to solve financial and administrative problems

#### Recommendation (13)

Imposing oversight by the Chairman of the Executive Council and his deputy on the literal implementation of the recommendations of the previous councils and the current council through visits to the organization's headquarters and ensuring the General Secretariat's commitment to what is stated therein, the transparency and clarity of all procedures and decisions, and not burdening the organization with personal costs outside the scope of contracts, the constitution, and internal regulations

Achieving this will be an effective step for progress and creating tangible development to reach the goals for which we are meeting, which is strengthening capabilities to help protect residents, property, and the environment and working with disasters and crises at the required professional level and through real cooperation and integration between everyone.
