HAVING CONSIDERED the matters submitted by the Secretary General,

APPROVES:

- To set up an ad hoc administrative commission composed of Algeria, Lebanon, Egypt, Kazakhstan and Pakistan. Its mandate will be to review Staff Regulations and Financial Regulations in order to adapt them to the Internal Regulations;
- To create a regional platform in Africa comprising a regional office, a regional training centre, a regional warehouse and a regional emergency center;
- To create a regional office located in Yaounde, Cameroon;
- To establish Portuguese as the 7th official language of ICDO;
- To set up a deadline not later than two weeks before the holding of the Executive Council and the General Assembly for the submission of candidacies to the position of President of the Governing Bodies as well as Members of the said Bodies;
- To set the limit for the number of Executive Council members at 25;
- To conduct consultations with voluntary Member States on the revision of the system of Honours and Awards of the International Civil Defence Order.

INVITES the aforementioned commissions to submit their reports to the 56th session of the Executive Council and the 26th session of the General Assembly.

INVITES the Secretary General to implement these decisions.
